**U**FCW Local 99 is pleased to announce the continuation of its college and vocational Scholarship Awards Program for the academic school year 2021-2022.

The union grants scholarships in the belief that it can make no finer investment than to provide better educational opportunities for deserving students.

Every member can take personal pride in the growth and development of this outstanding education assistance program.

Scholarships from \$500 and up will be awarded to deserving applicants.

**NOTE:** After an application is completed and submitted, applicants will be given the opportunity to write an essay to qualify for the interview stage of the scholarship competition. Instructions will be included regarding essay topics, length and other requirements. After essays are reviewed, applicants will be notified whether they qualify to advance to the final stage of the scholarship competition.

## RULES AND ELIGIBILITY

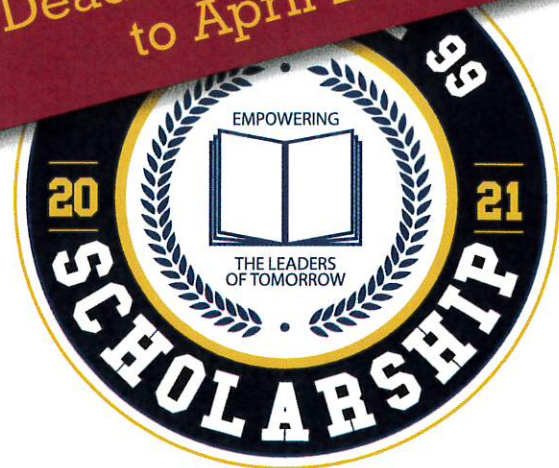
1. Applicants must establish basic eligibility for a scholarship award by completing the **UFCW LOCAL 99 SCHOLARSHIP AWARDS COMPETITION APPLICATION**. This application must be returned to Local 99 no later than **April 2, 2021**.

2. The applicant must be a member, a spouse of a member or a member's dependent who is 21 or younger. *(Dependents of retired members do not qualify.)*
3. The applicant must be at least a senior in high school.
4. Eligibility requirements state that the applicant must remain a member of UFCW Local 99 in continuous good standing through June 30, 2021. This means that the member on whose eligibility the applicant applied cannot be suspended, take a withdrawal or transfer to

another union local. Failure to comply through the eligibility requirements will disqualify the applicant from competition as an applicant, finalist or winner.

5. Fire and law enforcement academy applicants and cosmetology and electronics applicants may apply under the **vocational** category only.
6. An independent scholarship committee composed of leading citizens of the community will be responsible for selecting a group of finalists based on their essays. Finalists must submit additional information and appear before the committee for a personal interview. After the personal interviews, the committee will select the winners.
7. College awards are not restricted as to level of study.
8. Vocational awards are separate from college awards.
9. All awards are contingent upon the student being accepted by and registering at an accredited school.
10. Winners must be full-time students taking at least 12 units (undergraduate and vocational) or nine (graduate) for full-time awards and at least six units for part-time awards.
11. Decisions of the scholarship committee are final.
12. Applicants are not eligible if they previously received award monies.
13. Test scores from previous competitions are not accepted in the current competition.
